

Dear Parents/Guardians,

At BWE (International Student Guardianship Ireland), we are committed to ensuring the well-being and support of your child during their time in Ireland. To maintain the high standards of our services, we are implementing a Contingency Fund Policy. This fund is essential to cover various expenses that may arise during the student's guardianship period.

# **Contingency Fund:**

As part of our commitment to your child's safety and welfare, a Contingency Fund is established for unforeseen and miscellaneous expenses that may arise during their guardianship period. The minimum amount for this fund is set at €200 per student.

### **Benefits of the Contingency Fund:**

- · Immediate access to funds for emergency situations
- Streamlined and efficient handling of unforeseen expenses
- Transparency in financial transactions related to your child's guardianship

### **Policy Details:**

#### Advance Payments:

BWE will not process miscellaneous or unforeseen expense requests in advance. All such expenses will be settled using the Contingency Fund, and a detailed report will be provided to parents upon fund utilisation at the end of each term (December and May)

#### **Minimum Requirement:**

A minimum payment as per the duration of study is required to be provided in the Contingency Fund prior to school start. This amount ensures that immediate and

unforeseen expenses, such as medical emergencies or incidental costs, can be addressed promptly without delay.

#### **Fund Utilization:**

The Contingency Fund is designed to be versatile and can be utilised for any payment required for the student during their stay. This includes but is not limited to day-to-day and week-to-week expenses, school-related costs, clothing, additional books, medical expenses, and any other unforeseen expenditures that contribute to the student's well-being and overall experience during their guardianship period.

### Notification of Fund Usage:

In the event of utilizing the Contingency Fund, parents/guardians will be promptly notified, along with a detailed breakdown of the expenses incurred.

#### **Replenishment:**

It is the responsibility of parents/guardians to replenish the Contingency Fund to the minimum required amount after notification of usage. Parents will be notified should the fund fall below €50. Immediate replenishment is recommended to ensure uninterrupted coverage of the student's expenses.

### How to Replenish the Contingency Fund:

Funds can be replenished by making a direct transfer to the designated BWE account or via you booking agency. Details for fund replenishment will be provided in the notification of usage.

### **Refund or Carry Forward:**

Any remaining amount in the Contingency Fund at the end of the academic year will be refunded within 30 days of the completion of the programme. Alternatively, with the

consent of the parents, the remaining balance may be carried forward for the following academic year should a student wish to continue their studies for the next academic year.

## End-of-Year Settlement:

Refunds or carry-forwards will be processed at the end of each academic year. Parents will receive a detailed statement of the Contingency Fund transactions.

By enrolling with BWE, parents/legal guardians acknowledge and agree to adhere to the Contingency Fund and Payment Policy outlined in this document, recognizing its significance in ensuring the well-being and support of the student during their guardianship.
